YESTERDAY'S MINUTES: PART 2

The second in a series of articles reviewing the Parish Council minutes of the past. We enter 1947.

The first meeting of 1947 in April saw the first recorded full attendance of Councillors since the War (7 Councillors) and also the first subscription to the County Association of Local Councils. At that time the Clerk's salary was £2 p.a. The County Council required definition of footpaths in the parish. At a subsequent meeting, also in April, a map was marked with the paths as a record of rights of way which continues until this day.

In 1948 details of allotments were provided. Mr.Saunders who represented the parish on Gipping RDC was present. He reported progress made by the RDC in planning for a comprehensive water supply for the parish. Appreciation of the services of the late Clerk, Mr.Harry Harwood Simon, was recorded.

Onto 1949, and Mr.L.Bryant of Brdige Cottage, Hitcham, took over as Clerk at a salary of £4 p.a. and expenses. The signed precept form was not presented to the RDC because of the satisfactory balance in the General Account. Amongst papers received were posters for exhibition in connection with the National Insurance Act, 1948.

YESTERDAY'S MINUTES (Continued)

The revised procedures for Parish Council elections under the Representation of the People Act, 1948 came into force, and a new Council was elected and held its first meeting on Wednesday, 8th June, 1949 at 7pm. The Councillors were: E.H.Fayers, H.S. Pead, J.R.Proctor, H.J.Quinton, H.B.Rendle, R.G.Rushbrook and E.J.Ward. Mr.Rendle was elected to continue as Chairman.

When discussing the Suffolk Playing Fields Association Silver Jubilee Appeal Councillors Quinton and Ward recalled that a fund of approximately £20 to £30 had been raised by a fete held in the parish about 1936/7 and the whereabouts of the money was unknown. Enquiries went on until 1952 when the hunt was "held over".
